2. Copperas Creek/Mill Creek Updates

Still waiting on announcement of funding application, met with Jeff Boeckler and Chris Haring, both will provide a list of landowners to reach out to gauge interest for projects to address their resource concerns to be able to put down on grant application. Still waiting on payment for Lorentzen.

3. FY23 Staffing Changes

The NACD grant, which funds Deloian and Gates' positions, has some funds left over, typically used to fund Chris Haring for SSRP design. Since Copperas Creek grant has wrapped up Dawn wrote in for an admin internship position to assist with AC workload, as well as a 30 hr./week community development assistant through NACD grant but haven't received this funding yet. Forest Preserve district interested in revisiting shared Education Person position similar to past position but with RISWCD providing employment. Temple also spoke on possibility of giving part time Henry Co. AC some hours in Rock Island office. Parchert made motion to move forward to pursue new position and develop job description. Oak seconded. MOTION PASSED.
